- Representatives of commercial supporters and exhibiting companies can attend the CME activity at LAPS discretion but cannot engage in sales or promotional activities while in the space or place of the CME activity.
- Exhibit fees are not considered commercial support and will not be acknowledged as educational grants.
- The placement of exhibit tables is at the sole discretion of LAPS.
- The **Exhibitor/Supporter** agrees to abide by all requirements of the ACCME *Standards for Commercial Support of Continuing Medical Education* (copy supplied upon request).
- LAPS agrees to:
 - abide by the ACCME Standards for Commercial Support of Continuing Medical Education;

- acknowledge support from the Commercial Company in program brochures, syllabi, and other program materials;
- return funds due to cancellation of program.

Cancellation by Exhibitor - Exhibiting companies must send written notice of cancellation to LAPS. The date on which the notice is received is the official cancellation date. Cancellations sent via fax or emails are accepted. If the cancellation is received 30 or more days before the activity start date, 50% of the contracted exhibit fee will be refunded. If the cancellation is received less than 30 days before the activity start date, 100% of the contracted exhibit fee will be retained.

Adherence to Exhibitor Guidelines - It is the responsibility of exhibiting companies to distribute these conditions and guidelines to all representatives attending the CME activity and/or working the exhibit space.
